OSHA MANDATORY COVID-19 VACCINATIONS/TESTING UPDATE: On December 17, 2021, the 6th Circuit Court of Appeals allowed OSHA's Vaccination and Testing Emergency to move forward. OSHA requires private employers with 100 or more employees to be vaccinated or tested weekly. This means all SBC employees, which includes Para-transit drivers, line drivers and Shop employees must show proof of vaccination, if you have not already done so, or test weekly. Weekly updates and Newsletters will provide weekly on-site testing schedules.
